PRAYER: Writ petition filed under Article 226 of the Constitution of India to issue a writ of Mandamus, directing the first respondent i.e., the Commissioner, Disciplinary Proceedings Tribunal, Madurai to dispose off the disciplinary proceedings initiated against the petitioner in TDP No.4 of 2002 after necessary enquiries since criminal case ended in acquittal even on 05.08.2015 and the appeal filed by the State was also dismissed on 29.04.2022, within a specified time frame that may be fixed by this Court.

ORDER

By consent of both the parties, this writ petition is taken up for final disposal.

2.The limited prayer sought for in the present writ petition is for a direction to the first respondent to conduct enquiry and dispose off the Disciplinary Proceedings initiated against the petitioner in TDP No.4 of 2002.

3.Since the Disciplinary Proceedings is still pending and the criminal case against the petitioner was ended in acquittal, it would be appropriate to direct the first respondent to conduct enquiry and dispose of it expeditiously, within a stipulated time.

4.In view of the above observations, there shall be a direction to the first respondent to conduct enquiry and dispose off the Disciplinary Proceedings initiated against the petitioner in TDP No.4 of 2002, as expeditiously as
