ORDER

When the petitioners herein had sought for information as to outstanding amount payable under the Post Retirement Benefit Fund Scheme, through their request under the provisions of Right to Information Act, the respondent had informed the petitioners that some amount is payable to them, in their reply dated 09.02.2022.

3. In this connection, each of the petitioners herein are called upon to submit a fresh representation along with a copy of this order to the respondent herein. On receipt of such representations, the respondent shall consider the same within a period of eight (8) weeks from the date of receipt of the representations and disburse the eligible amount to them, together with interest at the rate of 6% per annum, from the date on which the amount is due to each of them.
