ORDER

This criminal original petition has been filed seeking a direction to the respondents to file final report in Crime No.3 of 2022, dated 03.02.2022.

2.The learned Counsel appearing for the petitioner submitted that the respondent police may be directed to file final report in Crime No.3 of 2022, for the offences under Sections 406, 420, 294(b) and 506(2) IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002, on the file of the respondent police.

3.The learned Government Advocate (Crl.Side) submitted that based on the complaint lodged by the petitioner, the respondent police registered an FIR in Crime No.3 of 2022, and for the same, investigation is in progress. Hence, he seeks three months time to file final report before the jurisdictional Magistrate Court.
