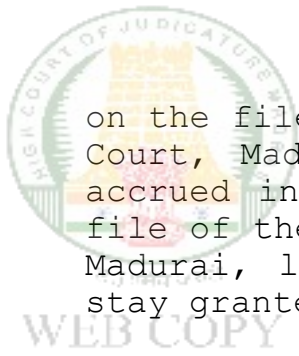

on the file of the Motor Accidents Claims Tribunal, Special District Court, Madurai, within a period of four weeks with proportionate accrued interest, to the credit of M.C.O.P.No.109 of 2018 on the file of the Motor Accidents Claims Tribunal, Special District Court, Madurai, less any amount already deposited, failing which, interim stay granted shall stand automatically vacated.
