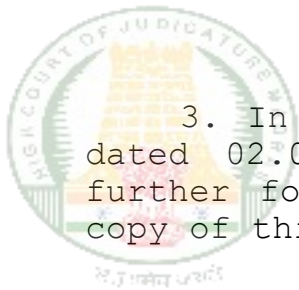

2. The learned counsel for the petitioners seeks time to produce sureties. Because of the attitude of the defacto complainant, the petitioners are unable to execute sureties within the stipulated time as per the order of Crl.O.P(MD) No.4087 of 2022 dated 02.03.2022.



3. In view of the same, time granted by this Court vide order dated 02.03.2022 in Crl.O.P(MD) No.4087 of 2022 is extended further for a period of fifteen days from the date of receipt of copy of this order.
