2.The learned counsel for the petitioner would submit that the petitioner has complied with the condition for a period of 9 days and that the petitioner may be directed to appear before the respondent police daily at 05.30 p.m., instead of 10.30 a.m., for the remaining days.

3.The learned Government Advocate (Criminal Side) appearing for the respondent has not raised any objection.



4. Considering the above, this Court is inclined to modify the condition and the petitioner is directed to appear before the respondent police daily at 05.30 p.m., for the remaining days and other conditions shall remain unaltered.
