Prayer in WP(MD) . 2358/ 2021 :

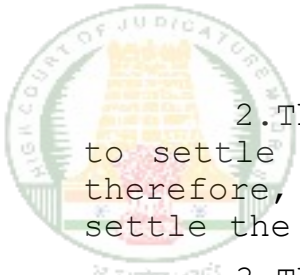
