This petition has been filed seeking a direction to direct the second respondent to register a case against the proposed accused on the basis of the order in CrI.M.P.No.52 of 2022, dated 15.02.2022 passed by the District Munsif Cum Judicial Magistrate Court, Authoor, Dindigul District.

2.The learned counsel appearing for the petitioner submitted that the petitioner has filed a private complaint under Section 156(3) of Cr.P.C. before the learned District Munsif Cum Judicial Magistrate, Authoor, Dindigul District seeking a direction to the second respondent herein to register a case on her complaint dated 20.12.2021. The learned Magistrate, by order dated 15.02.2022 in Cr.M.PNo.52 of 2022 directed the second respondent to conduct an enquiry, if necessary, F.I.R. is to be registered and send the report to the Court by 22.03.2022.
