Side) appearing for the respondent Police would submit that already the petitioner gave a complaint against the “Ayushu Nooru” Private Limited, Trichy and found that he had received the property worth of Rs.5,00,000/- and deposited the amount and he take back his compliant and no complaint is pending on the file of the 5th respondent.

3. The learned counsel appearing for the petitioner would submit that the complaint is not taken back by the petitioner and the same is pending before the 5th respondent.

4. In view of the said submission, the 5th respondent is directed to consider the representation of the petitioner, if any received from the petitioner and dispose of the same on merits and in accordance with law.

5. With the above direction, this Writ Petition is disposed of . No costs.
