To issue a Writ of Mandamus to directing the respondents to pay me surrender leave salary for 144 days of Rs.2,58,254 for the years 2011-2019 together with interest at the rate of 18 percentage p.a from the date of retirement to till the date of disbursement within the time that may be stipulated by this Honble Court and pass such further or other orders as this Honble Court may deem fit and proper in the nature and circumstances of the case and thus render justice.
