ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents to give the permission and adequate police protection for conducting Adal Padal Dance and Cultural Programme scheduled to be held on 09.07.2022 in the eve of Arulmigu 'Sri Karpagavinayar and Sri Palakattu Pagavathi Amman Temple' Aani festival belongs to Azhagagoundanpatti Post, Karuppur Village, Manapparai Taluk, Trichy District on the basis of the petitioner's representation, dated 29.06.2022.

2. The learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

The learned counsel appearing for the petitioner submitted that Aani Pongal Mandagapadi Festival for the temple, by name, Sri Karpagavinayar and Sri Palakattu Pagavathi Amman Temple' Aani festival situated at Azhagagoundanpatti Post, Karuppur Village, Manapparai Taluk, Trichy District is going to be held on 09.07.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving a representation dated 29.06.2022. But, the respondents have not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

4. The learned Government Advocate (criminal side) appearing for the respondent police would submit that the respondents have received the representation of the petitioner and the same is pending for consideration.
