3. The learned counsel appearing for the second respondent has no objection for this Court to appoint an election officer.

Since there is consensus on either side, I appoint Mr.V.Shathurthi Raja (Enrollment No.2723/2019) & Ms.Vedavalli (Enrollment No.7780/21) as election officers to conduct the petition mentioned election. The Sangam shall pay a consolidated remuneration of Rs.15,000/- each to the said election officers.
