This criminal original petition has been filed seeking to quash the FIR in Crime No. 918 of 2020, on the file of the Inspector of Police, Kovilpatti East Police Station, Kovilpatti, Thoothukudi District.

2.The learned Counsel appearing for the petitioner submitted that due to money dispute, the petitioner abused the second respondent with filthy language and also threatened the second respondent's staffs. Hence the complaint.
