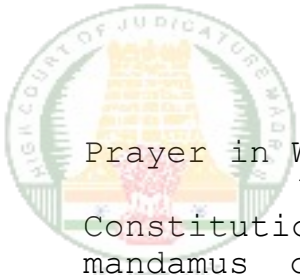

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus or any other writ, order or direction in the nature of Writ of Mandamus directing the respondents 1 to 3 herein to consider the representation of the petitioner dt 27.07.2020 to grant the selection grade pay with retrospective effect from 26.08.2007 along with all monetary benefits.



Prayer in WP(MD). 13089 of 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of mandamus or any other writ, order or direction directing the respondents 1 to 3 herein to consider the representation of the petitioner dated 25.08.2020 to grant the selection Grade Pay with retrospective effect from 01.06.2007 along with all monetary benefits.

Prayer in WP(MD). 12973/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus or any other writ, order or direction directing the respondents 1 to 3 herein to consider the representation of the petitioner dt 25.08.2020 to grant the selection grade pay with retrospective effect from 02.06.2007 along with all monetary benefits.
