Prayer in WP(MD). 4534 of 2021 :

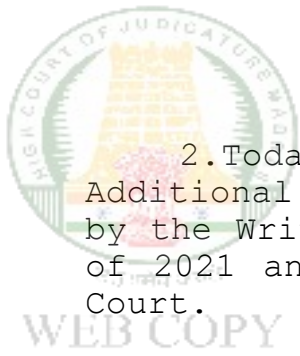

To issue an appropriate Writ, Order or Direction in the nature of a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceeding issued by the 4th respondent District Educational Officer o.mu.No.3344/A2/2020 dated 25.01.2021, quash the same and further direct the 4th respondent District Educational Officer herein to sanction the two advance increment to the petitioner for acquiring M.Sc., degree with effect from the date of her eligibility, and pass such further or other suitable order/ orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
