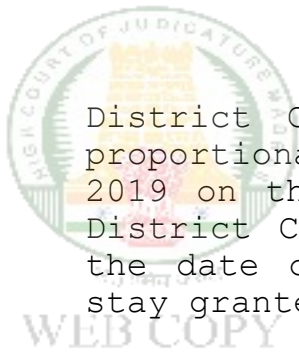

Prayer in CMA(MD). 1118/ 2022 :

Civil Miscellaneous Appeal filed under Section 173 of Motor Vehicle Act, to set aside the fair and decreetal order dated 23-03-2022 made in MCOP.No. 786 of 2019 on the file of the Motor Accident Claims Tribunal, (Special District Court to deal with MCOP Cases), Thanjavur, and allow this civil miscellaneous appeal.

District Court), Thanjavur, within a period of four weeks with proportionate accrued interest, to the credit of M.C.O.P.No.786 of 2019 on the file of the Motor Accidents Claims Tribunal, (Special District Court), Thanjavur, less any amount already deposited from the date of receipt a copy of this order, failing which, interim stay granted shall stand automatically vacated.
