When the matter is taken up today, the learned counsel for the respondents submitted that the advertisement for the post of Senior Lecturers, Lecturer-cum-Instructors, Assistant Lecturers and Teaching Associates published in Employment News, dated 7-13.05.2022 and published in the Institute's web-site is cancelled, for technical reasons.

3. When the very advertisement for want of aforesaid teaching professional is cancelled vide Public Notice, dated 13.07.2022, this Court is of the view that nothing survives to be adjudicated in this writ petition.
