He further submitted that the Block Development Officer is not a party in this petition, whereas, the Regional Development Officer has been shown as the third respondent.

4. Recording the submission of the learned Additional Government Pleader, this petition is closed with a direction to the Block Development Officer, Tiruverambur to take appropriate action in accordance with law for removal of the encroachments, if any.
