ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Mandamus, directing the respondents herein to grant permission and protection to conduct the Aadalum Paadalum dance programme on 14.07.2022 from 8.00 pm to 11.00 pm in pursuant to the Aani Festival of Arulmighu Sri Vembadi Muthumariamman Temple, Thirunallur North Village, Thirunallur Post, Aranthangi Taluk, Pudukkottai District, by considering the petitioner's representation dated 05.07.2022.

2. The learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the petitioner submitted that Festival for the temple, by name, Arulmighu Sri Vembadi Muthumariamman Temple situated at Thirunallur North Village,

Thirunallur Post, Aranthangi Taluk, Pudukkottai District is going to be held on 14.07.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving representation dated 05.07.2022 to the respondents. But, the respondent Police have not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

4. The learned Government Advocate (criminal side) appearing for the respondent police would submit that the respondents have received the representation of the petitioner and the same is pending for consideration.
