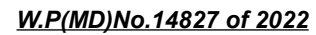
ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Mandamus, directing the respondents to grant permission and necessary protection to conduct the Adal Padal Programme on 17.07.2022 at 08.00pm to 11.00pm in connection with Thiru Vizha of Arulmigu Sri Kaliasman, Sri Karuppasamy, Sri Muniyandi Thirukovil, 93rd Ward, Gopalipuram, Madurai.

2. The learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the petitioner submitted that Festival for the temple, by name, Arulmigu Sri Kaliasman, Sri Karuppasamy, Sri Muniyandi Thirukovil situated at 93rd Ward, Gopalipuram, Madurai is going to be held on 17.07.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving representation dated 06.07.2022. But,



4. The learned Government Advocate (criminal side) appearing for respondent police would submit that the respondents have received representation of the petitioner and the same is pending for consideration.

5. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (criminal side) appearing for the respondent police.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc. 007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the
