3.Learned Government Pleader appearing for the respondents 1 to 5 submitted that S.F.No.270/2 is a patta land and it is not a Government land.

4.In the opinion of this Court, a Writ cannot be issued in anticipation that such a license is likely to be granted to the sixth respondent.

5.In the result, we find no merit in this Writ Petition, Accordingly, the same is dismissed. There shall be no order as to costs.
