ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, directing the respondents to give the permission and adequate police protection for conducting Adal Padal Dance Programme scheduled to be held on 13.07.2022 in the eve of Arulmigu Sri Maha ganapathi, Sri Balayi Mariyamman and Sri Masi Karuppanna Swami, temples Kumbabhiseka Vizha at Senthamangudi Village, Musiri Taluk, Trichy District on the basis of the petitioner's representation dated 05.07.2022.

2. The learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the petitioner submitted that Festival for the temple, by name, Arulmigu Sri Maha ganapathi, Sri Balayi Mariyamman and Sri Masi Karuppanna Swami, temples Kumbabhiseka Vizha situated at Senthamangudi Village, Musiri Taluk, Trichy District is going to be held on 13.07.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving representations dated 04.07.2022 and 05.07.2022. But, the respondents have not considered the said representations. Since no order was passed, the petitioner has come before this Court for the above said relief.

4. The learned Government Advocate (criminal side) appearing for the respondent police would submit that the respondents have received the representations of the petitioner and the same is pending for consideration.

5. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (criminal side) appearing for the respondent police.
