5.Considering the limited prayer sought for by the petitioner, taking into consideration of the fact that the suit is of the year 2019, and also it has been ripe for trial, this Court is inclined to dispose of this Civil Revision Petition with a direction to the learned Principal District and Sessions Judge, Dindigul to dispose of the suit in O.S.No.36 of 2019, within a period of six months from the date of receipt of a copy of this order.
