ORDER

The learned Additional Government Pleader submitted that the writ petition which pertains to this contempt petition and the other connected two writ petitions are now posted before the learned Single Judge for final hearing. The learned Additional Government Pleader also brought to the notice of this Court the orders passed by the Division Bench in C.M.P(MD)No.4970 of 2022 in W.A(MD)No.576 of 2022, dated 22.06.2022 wherein the proceedings of the District Collector, Pudukottai, dated 15.12.2021, has been stayed.
