### **ORDER**

2.The learned Standing Counsel for the first respondent would submit that appropriate procedure for such transfer of the EPF amount to the GPF Account shall be on Form 13 of the Employees' Provident Funds & Miscellaneous Provisions Act. It is his further submission that if such application is made, the same will be considered in accordance with law.
