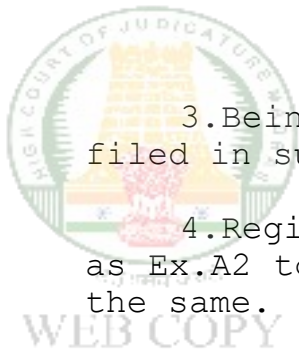
PRAYER IN SA(MD)No.170 of 2007:
