It is the case of the petitioner that his daughter Sherin Hudha aged about 19 years went missing from 20.06.2022 and that the police are not taking effective steps to secure her. Hence, the petitioner has filed the present Habeas Corpus Petition with the above prayer.

2.Heard Mr.S.M.A.Jinnah, learned Counsel appearing for the petitioner and Mr.T.Senthil Kumar, learned Additional Public Prosecutor who accepts notice on behalf of the respondents 1 and 2.

3.On instructions, learned Additional Public Prosecutor submitted that on the complaint given by the petitioner, a case in
