Prayer in WP(MD). 272 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of Certiorarified Mandamus, calling for the records relating to the impugned ineligible list of certificate verification published by the 2nd respondent vide his proceedings Nil dated 11.01.2020 (published in the official website of TRB) in so far as the petitioner is concerned and the consequential impugned proceedings No. NIL dated 28.12.2020 issued by the 2nd respondent (published in the Official Website of the TRB) and quash the same as illegal in so far as it relates to the non inclusion of the petitioners name is concerned and consequentially to direct the respondents to treat the petitioner as a candidate belonging to the Backward Class (Muslim) Community and consequently to appoint the petitioner as Computer Instructor taking into consideration of the marks secured by the petitioner within the period that may be stipulated by this Court.
