Prayer: Writ petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order passed by the 3rd Respondent in his proceedings RFL/Ottapidaram No.47/2021 dated 06.08.2021 and quash the same as illegal and consequently directing the 3rd Respondent to register the sale deed presented by the petitioner on 06.08.2021 in respect of punja land to an extent of 0.81.00 Hectares(2 Acres) situated in Resurvey No.489/3 Panchalankurichi Village, Ottapidaram Taluk, Thoothukudi District comprised in patta No.112.

ORDER

Heard the learned counsel appearing for the writ petitioner and the learned Additional Government Pleader appearing for the respondents.

2. The petitioner is the purchaser of the petition mentioned property. When the sale deed was presented for registration, the third respondent declined to register the same by citing the impugned communication issued by the Tahsildar.

3. The learned counsel appearing for the petitioner draws my attention to the order dated **16.10.2015** made in ***W.P(MD)No.17060 of 2015 (S.Muthalraj V. The Revenue Divisional Officer, Thoothukudi District)***. The



said writ petition also dealt with the very same issue. The said order was followed in a number of decisions. Since the case on hand is covered by the same, the impugned order is quashed. The registering authority is directed to register the petition mentioned sale deed and release the same subject to fulfilment of the usual formalities.

4. This writ petition is allowed. No costs.
