2.Today, when the matter was taken up for hearing, the learned Government Advocate for the respondent has produced the compliance report filed by the respondent and submitted that the appeal filed by the petitioner dated 13.03.2019 was considered and rejected. The relevant portion of the compliance report is extracted hereunder:-

“6.I humbly submit that as per the Kodaikanal modified Master Plan and the report of the Director of Town and Country Planning, the Government rejected the appeal dated 13.03.2019 filed by the appellant Tmt.Saras, Kodaikanal vide Government letter No.6149/UD4(L.Re)/2019-1, Housing and Urban Development Department, dated 23.03.2021. As per the orders of Hon'ble Madurai Bench of Madras High Court, the appeal has been disposed and orders complied with.”
