2. The sixth respondent is holding a mining license. The allegation of the petitioner is that the sixth respondent had acted contrary to the terms of the license. The fourth respondent is directed to enquire into the petitioner's complaint and pass final order on merits and in accordance with law within a period of twelve weeks from the date of receipt of a copy of this order.

3. I make it clear that I have not gone into the merits of the matter. The fourth respondent shall pass final order only after hearing the sixth respondent. It is open to the fourth respondent to pass final order one way or the other. This writ petition stands disposed of accordingly. No costs.
