COMMON PRAYER :-

For Anticipatory Bail in Crime No.105 of 2021 on the file of the Respondent Police

COMMON ORDER : The Court made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the offence under Sections 120B, 406, 420, 294 (b) and 506(2) IPC in Crime No.105 of 2021, seek anticipatory bail.

2.When the matter is taken up for hearing today, the learned Additional Public Prosecutor would submit that the matter has been compromised between the parties and based on that, the First Information Report in Crime No.105 of 2021 has been quashed by this Court in Crl.O.P.(MD) No.15298 of 2022, dated 25.08.2022 and hence, nothing survives for further adjudication in these cases.

3.Since the First Information Report in Crime No.105 of 2021 has been quashed by this Court, the question of arrest and anticipatory bail does not arise.

4.Accordingly, these Criminal Original Petitions are closed. Consequently, connected miscellaneous petitions are closed.
