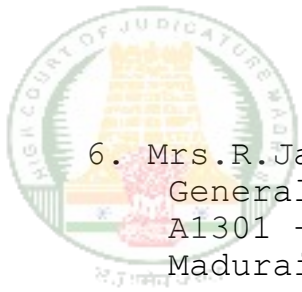

Prayer : Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents 1 and 2 to register the complaint and conduct enquiry and take necessary action against the respondents 3 to 6 herein and also other officers connected and colluded with them for abusing their power, collecting and misappropriating the money from 8840 Primary Milk Cooperative Societies to the tune of Rs.2,27,01,120/- (Rupees Two Crores Twenty Seven Lakhs One Thousand One Hundred and Twenty) for purchasing and providing three Record Note Books at a very high price of Rs.2,688/- per society throughout 29 Circles in the State, based on the representation given by the petitioner dated 29.07.2020 forthwith, within the time stipulated by this Court.
