Since the parties have arrived at an amicable settlement, no purpose will be served in keeping the impugned prosecution alive. The parties have also filed a joint



compromise memo. The impugned FIR is quashed. The Criminal Original Petition is allowed. Consequently, the connected miscellaneous petition is closed.
