This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, directing the respondents to grant permission and police protection to conduct Kabadi Tournament from 13.08.2022 at about 10.00 a.m to 14.08.2022 at 10.00 pm at Kaliyamman Thidal, Saravanapatti, Kumaravadi, Manapparai Taluk, Trichy District.

2.Mr.M.Sakthi Kumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that the petitioner has decided to conduct Kabadi Tournament from 13.08.2022 at about 10.00 a.m to 14.08.2022 at 10.00 pm at Kaliyamman Thidal, Saravanapatti, Kumaravadi, Manapparai Taluk, Trichy District. Hence, he sought permission of the police by giving a representations dated 04.07.2022 and 11.07.2022. But, the respondents have not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representations of the petitioner, dated 04.07.2022 and 11.07.2022 and pass suitable orders based on the above said circular.
