This Court by an order dated 17.06.2022 in Crl.M.P(MD) No.6754 of 2022 in Crl.O.P(MD) No.7854 had directed the learned Magistrate to receive the demand draft and credit the said amount to the credit of Crl.M.P.No.1347 of 2020 in M.C. No.14 of 2020. As directed by the Court the said amount was deposited. Now the petitioner herein seeks permission of this Court to withdraw the said amount.

3. The learned counsel appearing for the respondent did not raise any objection for withdrawing the amount.

4. In view of the same, this Criminal Miscellaneous Petition is allowed and the petitioner is permitted to withdraw a sum of Rs.2,50,000/- paid by the petitioner before the learned Judicial Magistrate, Thiruvudaimaruthur.
