According to the learned counsel for the petitioner, the rent arrears due from the respondent is more than Rs.3,34,400/-. It is also stated that the respondent is evading without filing the written statement. The learned counsel further submits that the petitioner's husband died on 06.05.2022 and the suit property is the only income for her survival. Hence, she filed the present Civil Revision Petition for early disposal of the suit in O.S.No. 599 of 2021.

3.Though notice was served on the respondent, there is no representation for the respondent either in person or through counsel.
