Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records in connection with the impugned order in Na.Ka.No.1/C/2022 dated 09.07.2022 on the file of first respondent office transferring second respondent to the Nagercoil Government Arts and Science College overtaking the seniority

ORDER

Though the petitioner herein had challenged the order of transfer of the second respondent herein, dated 09.07.2022, the learned counsel for the petitioner submitted that he is not pressing for such a prayer to quash the order of transfer of the second respondent and that he would be satisfied, if the request of the petitioner for transfer is considered by the first respondent herein within a time frame.

2. According to the learned counsel for the petitioner, there is a vacancy at the Government Arts and Science College, Nagercoil in the post of Assistant Professor (Science), apart from the post to which the second respondent herein has been transferred. In this regard, the petitioner also claims to have given a request to the first respondent on 18.01.2022, which is pending.
