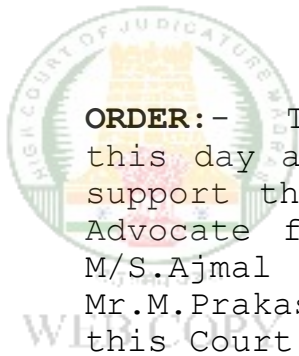

Prayer in WP(MD) . 2886/ 2017 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the respondents 1 to 4 to waive the complete course fee of Rs.93,460/- to the petitioner by implementing the guidelines laid down in G.O.Ms.No.92 11.09.2012 and to declare M.Tech., (Computer & Information Technology) Final year (3rd and 4th Semesters) result, to issue mark list and degree certificate of the petitioner for 3rd and 4th semesters by taking into account the representation dated 12.12.2015.
