4.When the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent police reports that on receipt of the complaint, the respondent police conducted the investigation and registered a case in Crime No.518 of 2021 as against the petitioner and in fact, he was arrested and released on bail.

5.Under such circumstances, once the regular FIR has been registered, the question of "Not to harass" will not arise. Any direction issued by this Court at this stage will amount to interfering with the investigation conducted by the respondent police.

6.With the above observation, this Criminal Original Petition is dismissed.
