Call on 29.08.2022 'for reporting compliance'.

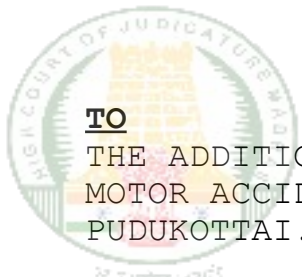
