The prayer sought in the Writ Petition is to direct the second respondent to consider the representation of the petitioner, dated 20.08.2020.

2. According to the petitioner, he is the original borrower and co-applicant in respect of the loan availed by his father from the third respondent and his loan account was converted into NPA Account, but no such notice was served upon him. Hence, the petitioner made a representation, dated 20.08.2020 to the second respondent to grant some more time for initiating the illegal proceedings before the appropriate forum till the lifting of lock down.
