Prayer in CRL OP(MD). 13576/ 2022 :

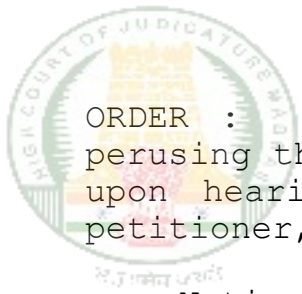
