9. In addition, the recognition of the Tamil Nadu Throwball Association for Men and Women shall be revoked after the approval of the Executive Committee of SDAT. ”

4. In the light of the said stand, no further orders are necessary in this writ petition. This writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
