3.The learned Government Advocate (Crl. Side) submitted that the petitioner is having one previous case in similar nature.

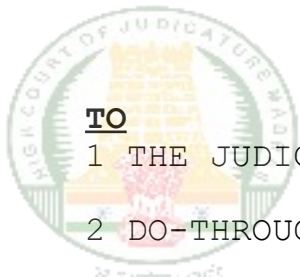
