In this regard, the petitioner is at liberty to approach the competent authority for the redressal of his grievances. However, the contempt petition need not be kept pending unnecessarily, as the direction issued by this Court is for settlement of terminal benefits and calculation or otherwise, if objected, to be redressed in accordance with the procedures.
