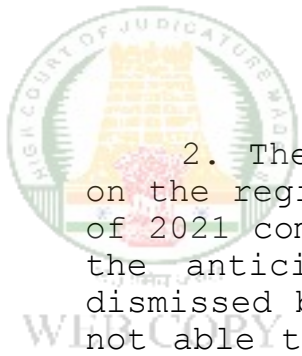

Though the anticipatory bail filed by some of the accused have been dismissed by this Court, they are absconding and as such they could not able to secure the accused, however they are about to complete the investigation and the third respondent will file the final report.

4. Considering the above, the second respondent is directed to complete the investigation and file the final report within a period of twelve weeks from the date of receipt of a copy of this order. The first respondent is directed to monitor the investigation done by the second respondent.

5. With the above direction, the Criminal Original Petition stands disposed of.
