Prayer in WP(MD) . 20635/ 2018 :

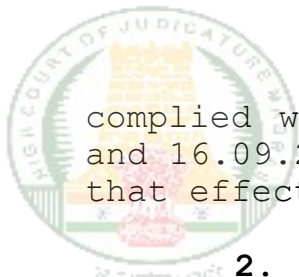
