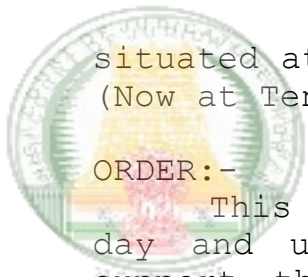
Prayer in WMP(MD) No.12171 of 2022:-
