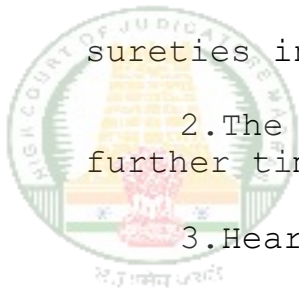
Prayer in CRL OP(MD)12289 OF 2022
